Self-paced online lab guiding students through graded problem sets on key microeconomics tools and concepts.

I will provide students with the lecture slides from the 7<sup>th</sup> edition of the book in the file section of the Canvas website. If you cannot find the answer in the slides or want a different explanation, you have two options—come to my office hours for help or purchase the textbook. If you decide to purchase the book, I highly recommend buying an older edition (6<sup>th</sup> or 7<sup>th</sup>) as the material has not changed much in recent editions and the older editions sell at a significant discount to the current edition's price.

#### **Course Requirements and Assignments**

SJSU classes are designed such that in order to be successful, it is expected that students will spend a minimum of forty-five hours for each unit of credit (normally three hours per unit per week), including preparing for class, participating in course activities, completing assignments, and so on. This is a pass/no pass course. You must achieve a cumulative score of 80% at the end of the semester. Your score is based solely on fourteen online assignments on the course's Canvas website. The assignments are due by 11:59pm on the Sunday of the week assigned—students will also be able to see the due dates in Canvas. (For a complete list of due dates, please see the last two pages of the syllabus.) However, all of the assignments will be available at the beginning of the second week so students can complete them ahead of time. Late assignments will not be accepted. However, I will drop your two lowest assignment grades at the end of the semester.

The assignments will follow a similar pattern and include two parts. The first half of each assignment will consist of ten multiple choice questions. Students will select their answer directly in Canvas. The second half will consist of two short answer questions with multiple parts. How students respond to the short answer questions will depend on the type of question. For short answer questions requiring only written answers, students will be provided a text box to provide their answer. For short answer questions requiring any drawing (i.e., graphs, table, and etc.), students will need to upload a photo (i.e., Jpeg or PDF) of their answer in the prompt at the end of the question.
