## **Course Description**

Analysis of the relations between industry structures, business conduct and economic performance under conditions of limited governmental interference. Appraises the role of competition and monopoly in the American economy. Stresses the role played antitrust laws and regulatory commissions in the US economy.

## **Course Requirements and Assignments**

- There are four components to your grade: three exams (50%), quizzes/class activities (20%), three presentations (15%), and three homework assignments (15%).
- The exams will have short answer questions. The first two shorter exams will be on 3/4 and 4/15. The exams will focus on material covered since the previous exam and are worth 15% each. The final exam is on May 20 between 7:45 and 10:00pm. The final exam is comprehensive and worth 20%.
- There will be about 10 in class quizzes and activities. Only the 7-8 highest scores will count toward your final grade. The scores after the 8<sup>th</sup> quiz will be extra credit for a potential max of 3 points added to your overall final grade. **No makeup quizzes.**
- Students will make three fifteen-minute presentation in class. The presentation will summarize and discuss selected articles.
- There will be three homework assignments. The assignments will be due a week before each of the exams: 2/25, 4/8, and 5/13.
