- b. CFAC's report to President, including any specific recommendations
 - i. Question to group, what actions have come out of the outcome report review?
 - 1. Group found benefits in having a chance to review outcomes and repurposing of SSETF
 - 2. From the time of approval to the review, over a three year period, many things can happen that would require the funds to be repurpose for other appropriate use
 - 3. Gives the appropriate oversight when the committee reviews the repurposing proposals
 - ii. What other option would be available if the committee did not review the outcome reports?
 - 1. Budget Office would review from samples of the reports and alert the committee of any problems with the use of funds
 - iii. Question: Are the funds meeting their intended purpose? Answer: Committee members agreed funds were helping students
 - iv. (AM) Gives a better prospective on the overall use of the funds and how the students are benefiting
 - v. (MG) Will send out last CFAC report to the President for group to review and contribute to the new report, which will be discussed at the April 17, 2020 meeting
