ABOUT AB540

AB 540 is an assembly bill that was signed into law in 2001. The law allows any student, including undocumented students, to pay in-state tuition at any California public institution if they meet certain criteria.

To be eligible as AB540, students must:

- Attend a California high school for three or more years
- Graduate from a California high school or receive the equivalent general education diploma (G.E.D.)
- Register or be currently enrolled in a California community college, CSU or a UC
- Sign a statement (affidavit) with a college or university stating that he/she will apply for legal residency as soon as possible
- Students may not hold a valid non-immigrant visa (i.e. F, J, H, L, A, E, etc.)
